

**VILLAGE OF GROSSE TETE MINUTES  
REGULAR MEETING  
August 9, 2018**

The Board of Alderman of the Village of Grosse Tete held their regular meeting at the Town Hall in Grosse Tete August 9, 2018 at 6:00 p.m.
