## VILLAGE OF GROSSE TETE MINUTES REGULAR MEETING January 13, 2021

**Appoint Clerk** - A motion was made by Alderman Clint Seneca to appoint Pamela H George as Municipal Clerk. This motion seconded by Alderman Marcus Hill and passed 3 – 0.

**Appoint Town Attorney** – A motion was made by Alderwoman Jeanie David and seconded by Alderman Marcus Hill to appoint Robert Marionneaux, Attorney at Law as the Town Attorney. This motion passed 3 -0.

**Appoint Fire Chief** – A motion was made by Alderman Marcus Hill and seconded by Alderman Clint Seneca to appoint Michael Hughes as Fire Chief for the Village of Grosse Tete. This motion passed 3 – 0.

**Appoint Mayor Pro Tem** – A motion was made by Alderman Marcus Hill and seconded by Alderman Clint Seneca to appoint Alderwoman Jeanie David as Mayor Pro Tem. This motion passed 3 – 0.

**David Crain** – David Crain, a citizen of the Village of Grosse Tete addressed the Mayor and Board of Alderman about speeding along Bayou Road. After discussion, it was decided to add an additional speed bump on Bayou Road.

Alderman Marcus Hill inquired about speeding on Solari Lane and Willow Street. After discussion, it was decided that a survey would be sent to each resident along Solari Lane as well as Willow Street from Eddie's Food Mart north to Solari Lane to help the Board of Alderman decide if Speed Bumps would be beneficial to that area. That information will be brought back to the Board of Alderman in February.

**Minutes:** Alderman Marcus Hill made a motion to dispense with the reading and approve the minutes of the Regular Meeting of December 10, 2020. The motion was seconded by Alderman Clint Seneca and passed 3 - 0.

**Finances:** Alderman Marcus Hill made a motion to approve the financial statements of December 31, 2020 as presented. This motion was seconded by Alderman Clint Seneca and passed 3 – 0.

## Mayor's Report:

Attorney Robert Marionneaux has been working on a Servitude Agreement with owners of the Holliday Property where the proposed bypass road will be constructed. Due to Covid-19, a meeting of the board of directors for Holliday Property has not been held and therefore the servitude has not been approved.

Mayor Chauffe stated that he has been in contact with Union Pacific Railroad about the blocking of the tracks in Grosse Tete. They assured him that they would work toward a solution to this problem.

The Waterline project in Angelloz Subdivision has begun.

The additional parking lot at the walking trail was completed and the paint has started to peel. The contractor will stripe again.

## Police Department – No Report
